

R 22 Line of Travel (LOT) (by Laura Parker)

April 23, NOT official USPS LOT

- RIGHT on JFK out of PO parking lot, RIGHT on BOARDWALK, LEFT on HARMONY
- RIGHT on S LEMAY – RIGHT into parking lot @ 4825 S LEMAY (CHURCH) to [stickbox](#)
- Retrace out of parking lot, RIGHT on S LEMAY
- RIGHT into parking @ 5505 S LEMAY (COLLINWOOD ASSISTED LIVING) – W(alk)I(n)
- Retrace back to RIGHT on S LEMAY, RIGHT on SOUTHRIDGE GREENS BLVD, RIGHT into MIRAMONT VILLAGE (950), LEFT to **CBU 1**
- Retrace, RIGHT on SOUTHRIDGE GREENS BLVD, u-turn to **CBU 2** on the left (before Belvedere Pl)
- Continue, RIGHT on CONDOR DR – turns into NIGHTINGALE DR- to **CBU 3** after the curve
- Continue to **CBU 4**, u-turn, LEFT on SCARLET IBIS LN, RIGHT on SOUTHRIDGE GREENS, RIGHT on S LEMAY
- RIGHT on FOSSIL CREEK PKWY, LEFT on PHILIPS DR to **CBU 5**
- RIGHT on PARLIAMENT CT to **CBU 6**, continue, LEFT on E SKYWAY DR
- RIGHT on AUBURN DR, RIGHT on ST MICHAELS DR, u-turn to **CBU 7** on the left
- LEFT on AUBURN, LEFT on SKYWAY DR, RIGHT on FOSSIL CREEK PKWY to **CS** on [FOSSIL CREEK](#)
- RIGHT on S LEMAY, RIGHT @ 6203 S LEMAY (RESPITE CARE) to **CS BOX** (attached to building)
- Retrace out of parking, RIGHT on S LEMAY, RIGHT on BRITTANY ST, LEFT into parking @ [6501 BRITTANY \(CHURCH\)](#) to **CS BOX** in parking lot
- Retrace to BRITTANY ST, LEFT on BRITTANY, RIGHT on WESTBOURN CIR to **CBU 8** after curve
- Continue - WESTBOURN turns into COURTENAY CIR- to **CBU 9** after a couple more curves
- LEFT on BRITTANY, cross S LEMAY – now HAWKEYE ST- RIGHT on FINCH CT, u-turn to **CBU 10** on the left
- Continue, RIGHT on HAWKEYE to **CBU 11**, LEFT on CANVASBACK to **CBU 12**
- Continue, RIGHT on S LEMAY, RIGHT on PARAGON PL to **CBU 13**
- Continue to **CBU 14 & 15**
- U-turn, RIGHT on PHEASANT DR, u-turn to **CBU 16** on the left
- U-turn again, continue to **CBU 17**, u-turn, LEFT on PHEASANT DR, RIGHT on S LEMAY

- RIGHT on SOUTHRIDGE GREENS BLVD, RIGHT on MUIRFIELD WAY to CS BOX for 5750 S LEMAY (Mackenzie's Pub & Grill ?)
- RIGHT on WINGFOOT to CBU 18
- U-turn, retrace on WINGFOOT, u-turn to CBU 19 on the left.
- U-turn again, RIGHT to stay on WINGFOOT, RIGHT on SOUTHRIDGE GREENS
- RIGHT on FRONT NINE DR to CBU 20 @ intersection FRONT 9 / HUMMEL
- Continue on FRONT 9 to CBU 21, RIGHT on HUMMEL LN, RIGHT on SOUTHRIDGE GREENS to CBU 22, continue to CBU 23
- RIGHT on CENTER GREEN BLVD, LEFT on GLEN EAGLE CT to H(ard)S(hip) @ 1438 GLEN EAGLE CT
- Retrace, LEFT on SOUTHRIDGE GREENS, RIGHT on FAIRWAY 6 DR, LEFT on FRONT 9 DR to CBU 24
- U-turn, LEFT on FAIRWAY 6, LEFT on FAIRWAY 5 to CBU 25 & 26
- LEFT on FRONT 9 DR, RIGHT to get to "frontage road", LEFT to CBU 27, continue to RIGHT on FRONT 9 DR, RIGHT on SOUTHRIDGE GREENS, RIGHT into parking lot @ 5450 S LEMAY (CHURCH) to CS BOX
- Retrace, RIGHT on SOUTHRIDGE GREENS, RIGHT on S LEMAY
- RIGHT on RULE, LEFT into parking @ 4824 S LEMAY (HEALTH & REHAB FACILITY) – W(alk)I(n)- switch out tubs behind desk & empty outgoing mail box on wall
- Retrace, RIGHT on S LEMAY, LEFT on HARMONY, RIGHT into parking lot @ 608 E HARMONY to CBU 28
- Retrace, RIGHT on E HARMONY to last CS BOX @ 530 E HARMONY
