

## R 23 Line of Travel (LOT)

January 23, NOT OFFICIAL USPS LOT

RIGHT on JFK out of PO parking lot, RIGHT on BOARDWALK, LEFT on HARMONY, RIGHT on TIMBERLINE, LEFT on CARPENTER / E COUNTY RD 32

- RIGHT on EAGLE RANCH RD to [CS – follow mail](#)

### BUSINESSES:

- RIGHT on E COUNTY ROAD 32, RIGHT on WESTGATE DR, RIGHT into ARBY's to [CS @ 7601 WESTGATE DR](#)
- Continue out of parking, RIGHT on ROYAL VISTA CIR, immediately RIGHT into parking to [CBU 1 @ 4650 ROYAL VISTA CIR](#) (Summit Speech Therapy) by entrance door
- Continue straight on this street to CBU 2 @ 4630 ROYAL VISTA CIR
- Continue straight out of parking area, LEFT on ROYAL VISTA CIR
- RIGHT [@ 7645 WESTGATE DR – AMERICAN INN](#) by WYNHAM to [CS](#) by front entrance
- Continue through parking, first possible RIGHT, RIGHT on WESTGATE DR, LEFT into parking area [@ 7640 WESTGATE DR – COLORADO EARLY COLLEGES](#), LEFT again in parking lot to [CS BOX](#)
- RIGHT on ROYAL VISTA CIR, RIGHT into parking [@ 4755 ROYAL VISTA CIR – WESTGATE KINDERCARE](#) – circle through parking lot to get to [CS](#) box
- RIGHT on ROYAL VISTA CIR, LEFT into [TACO JOHN'S](#), u-turn to [CS @ 4750 ROYAL VISTA CIR](#)
- RIGHT on ROYAL VISTA CIR, RIGHT into [LOAF N JUG](#) to [CS BOX \(7600 WESTGATE DR\)](#) close to exit / entrance by Westgate Dr
- RIGHT on WESTGATE DR, cross E COUNTY RD 32, through round about to retrace on WESTGATE DR, RIGHT into parking area [@ LIQUOR STORE](#) to [CBU 3](#)

### RESIDENTIAL:

- Retrace to WESTGATE DR, RIGHT onto WESTGATE, LEFT on E COUNTY RD 32, RIGHT on S CO RD 5
- [RIGHT on N HATHAWAY LN – CS / follow mail \(see map 3a / b\)](#)
- RIGHT on S CO RD 5, LEFT on SCHOONER LN, first LEFT into round street [@ NOCO ICE CENTER](#) to [CS 7850 / 7900](#)
- Continue, LEFT on SCHOONER LN, first RIGHT into parking area [@ businesses](#) to [CBU 4](#)
- Retrace to S CO RD 5, turn LEFT
- RIGHT on COUNTrY FARM RD to [CBU 5](#)

- Continue, LEFT on LOUDEN CIR, RIGHT on LOUDEN CROSSING CT to **CBU 6**
- U-turn, stay on LOUDEN CROSSING to **CBU 7**
- Continue, RIGHT on COUNTRY FARM RD - turns into HIGHLAND COVE DR after crossing S CO RD 5, RIGHT on HIGHLAND MEADOWS
- RIGHT on SAND DOLLAR DR to **CBU 8 & 9**
- Continue, RIGHT on ANNAPOLIS DR, immediately LEFT into HIGHLAND MEADOWS DENTAL @ 8201 SPINNAKER BAY to **CBU 10** by front entrance
- Continue out of parking, RIGHT on SPINNAKER BAY to **CBU 11**
- U-turn, retrace on SPINNAKER BAY to **CBU 12**
- Continue, RIGHT on ANNAPOLIS DR, RIGHT on ALBACORE CT to **CBU 13**
- Retrace, RIGHT on ANNAPOLIS DR, LEFT on CASTAWAY DR to **CBU 14**
- Continue on CASTAWAY DR to **CBU 15**
- U-turn, RIGHT on ANNAPOLIS, cross S CO RD 5
- 2<sup>nd</sup> RIGHT CROMWELL CIR to **CBU 16**, continue on CROMWELL CIR - turns into CROMWELL DR - to **CBU 17** on the left
- Continue, RIGHT on LONGSHAW CT, RIGHT on ANNAPOLIS to **CBU 18**
- Continue, LEFT on S CO RD 5, cross E COUNTY RD 32
- Take 3<sup>rd</sup> exit in round about onto OAKMONT ST, first RIGHT on CYPRESS PT DR
- RIGHT on SHADY OAKS DR, LEFT on WHISTLING STRAIGHTS DR to **CBU 19** on the left
- Continue to **CBU 20**
