MAP 1

ohne Gewähr

- RIGHT out of parking lot, RIGHT on HORSETOOTH, LEFT on TIMBERLINE
- RIGHT @ 2908 TIMBERLINE CHURCH, turn LEFT in parking lot to CBU
- Continue through parking lot, LEFT on ILLINOIS, immediately LEFT again, turn RIGHT into parking lot @ 2117 CUSTER – ESPIRE DENTAL to CBU by entrance
- Retrace out of parking lot. Turn RIGHT and RIGHT again to W @ 2111 CUSTER – MOUNTAIN VIEW EYE CENTER
- RIGHT on CUSTER, LEFT on ILLINOIS, next possible LEFT into business parking lot to CBU @ 2602-2644 TIMBERLINE
- Continue through parking lot, RIGHT on TIMBERLINE

MAP 2

- LEFT on NANCY GRAY, RIGHT into parking to CBU @ 2040 NANCY GRAY – CHURCH / PRESCHOOL
- RIGHT on JOSEPH ALLEN, RIGHT into business parking lot (before Bear Mountain, RIGHT to CBU
- U-turn, RIGHT on BEAR MOUNTAIN to CS @ 2101 TIMBERLINE (Burger King)
- U-turn, RIGHT on nameless street toward Dutch Brothers CS
- After DUTCH BROTHERS LEFT to CBU
- U-turn, LEFT to CS @ Big O Tires and Serious Texas
- Continue, RIGHT @ strip mall businesses to CBU @ 1925 Timberline
- Retrace, LEFT on JOSEPH ALLEN to CS @ 2103 (STOR-N-LOCK)

MAP 3

- Continue to 2555 JOSEPH ALLEN (Assisted Living) – W CBU:
 - Use arrow key to get the key fob by front door to the right
- Retrace, LEFT on JOSEPH ALLEN, LEFT on SPRING FARM DR, RIGHT on ADOBE DR to CBU Adobe

MAP 4

- Continue, RIGHT on NANCY GRAY, LEFT on TIMBERLINE, RIGHT on MIDPOINT, first RIGHT, RIGHT into parking lot @ 2121 MIDPOINT – W CBU – walk in, CBU is on the wall to your left

- Out of parking, RIGHT, U-turn to **CS @ 2155 MIDPOINT**
- Retrace, cross MIDPOINT, RIGHT to **CBU** on the left
- Continue, cross SPECHT POINT RD into business parking lot, TURN RIGHT in parking lot to **CBU (1600/1612 Specht Point)** on your left
- Retrace, continue through parking lot to **CBU (1601 / 1613 Prospect Parkway)** on the other side of the building
- RIGHT on PROSPECT PARKWAY, RIGHT on MIDPOINT, LEFT @ **2255 MIDPOINT (Halfway House)**, WALK IN mail tub and all parcels
- Continue in parking lot to **2307 MIDPOINT – Work release – WALK** mail tub and parcels INTO the second door
- Continue in parking lot to **2405 MIDPOINT – Larimer County Jail – WALK** mail tub and parcels IN
- Out of parking lot area, RIGHT on MIDPOINT, RIGHT @ **2501 MIDPOINT – Sheriff Department – WALK** mail and parcels IN

MAP 5

- Retrace to MIDPOINT, turn RIGHT to **CS boxes**
- Continue, RIGHT into parking to **CBU @ 2555 MIDPOINT** on the left
- RIGHT on MIDPOINT, RIGHT into parking to **2 CBUs @ 2573 / 2601 MIDPOINT**
- RIGHT on MIDPOINT, RIGHT into parking to **2 CBUs @ 2619/2625 & 2637/2643 MIDPOINT**
- RIGHT on MIDPOINT to CS 2655 MIDPOINT
- Continue, LEFT on SHARP POINT DR, LEFT @ **1625 SHARP POINT – ADVANCED ENERGY – W** all mail / parcels for **1625 SHARP POINT / 2424 MIDPOINT**
- Out of parking lot, Retrace / RIGHT on SHARP POINT, RIGHT into parking @ 1725 SHARP POINT – LIBERTY COMMON SCHOOL – to CS box
- Continue, LEFT on MARCH CT, park & walk across lawn to CBU @ 1825 SHARP POINT
- RIGHT on SHARP POINT, RIGHT on CANTON to CBU @ 1901 SHARP POINT
- Continue on CANTON, keep RIGHT into parking @ 2600 CANTON to CBU at the end of parking lot
- Retrace, RIGHT on SHARP DR to **CS boxes**
- RIGHT on MIDPOINT to **CBU @ 2642 (DOHN CONSTRUCTION) / 2636 MIDPOINT**
- RIGHT on MIDPOINT – finish **business CS** along MIDPOINT

- RIGHT on PROSPECT PKWY, next RIGHT into business area, RIGHT to CBU @ 2400 MIDPOINT # 101 ? , continue driving east in parking area to CBU @ 2400 MIDPOINT # 107?
- Retrace on the other side of the parking area to CBU @ 1600 / 1612 PROSPECT PKWY

MAP 6

- Retrace back to PROSPECT PKWY – turn RIGHT
- RIGHT on PROSPECT RD, LEFT after Orthopedic Center of the Rockies to CBU @ 2620 PROSPECT
- Retrace, RIGHT on PROSPECT RD, RIGHT into ORTHOPEDIC CENTER OF THE ROCKIES @2500 PROSPECT RD – stay / turn immediately RIGHT to get to the back entrance (see MAP 6)
 - WALK IN to the door at the dead end – DOOR CODE: #092254
 - WALK IN, go to the right into the mail room to leave MAIL TUB
- Retrace to the front of the building, through the parking lot to WALK IN @ 2420 PROSPECT (FC MRI)
- Next is WALK IN @ 2362 PROSPECT (TRI LIFE HEALTH)
- Travel WEST in the parking area toward MOUNTAIN SAGE SCHOOL – U-turn to CBU on the left
- Continue, RIGHT to exit this area, RIGHT on PROSPECT RD

MAP 7

- RIGHT into parking @ 2100 PROSPECT RD – SUTHERLAND LUMBER to CS box
- Retrace out of parking lot, RIGHT on PROSPECT, cross TIMBERLINE, first RIGHT into parking @ 2000 PROSPECT – BATH NURSERY to CS
- Travel through parking lot to exit RIGHT onto TIMBERLINE
- LEFT on PROSPECT RD

MAP 8

- CS @ 3501 PROSPECT – EWING EARTH RECYCLING
- Continue on PROSPECT RD, RIGHT at REST AREA ACCESS RD – U-turn @ CS boxes
- CROSS PROSPECT to the north side – retrace on PROSPECT for CS boxes @ 3716 – 3524 PROSPECT RD
- U-turn @ SUMMIT VIEW DR to go back EAST on PROSPECT RD

MAP 9

- Cross I 25, RIGHT on SE FRONTAGE RD – CS
- FRONTAGE RD turns into COUNTY ROAD 40 – CS
- Continue a while on CR 40 (cross S CO RD 5), U-turn @ 6644 COUNTY RD – Retrace on CR 40 / SE FRONTAGE RD – CS
- RIGHT on STABLE DR to CS boxes
- Retrace, RIGHT on SE FRONTAGE RD – CS
- RIGHT on PROSPECT RD – CS

MAP 10

- RIGHT on MEADOWAIRE to CS
- U-turn @ S CO RD 5 & retrace
- RIGHT on CARRIAGE RD -CS
- RIGHT on PROSPECT RD, RIGHT on CAREFREE DR, RIGHT on ENCHANTMENT – CS (follow mail)
- RIGHT on PROSPECT – CS @ 5901
- U-turn & retrace
- LEFT on S CO RD 5 – CS along S CO RD 5
- LEFT on E CO RD 42E – U-turn to CS BOXES on the left
- LEFT on S CO RD 5 – CS

MAP 11

- RIGHT on SECOND AVE, LEFT on DIXON ST, U-turn at dead end & retrace to CS on DIXON ST
- RIGHT on 3rd AVE to CS @ 4120 3rd AVE
- RIGHT on S CO RD 5 / MAIN STREET to CS
- END ROUTE @ CS 4409 MAIN STREET
