

Form Post Office Parking Lot Turn Right on S. Meldrum St. Left on W. Mountain Ave. Right on N. Shields St. to **CS 1 – 802 – 930 N. Shields St.**

Turn Right on W. Vine (CR48) (first exit at roundabout). **CS 1 – 1100-1619 W. Vine Dr. (Seq 1-29)**

Right on Lancer DR. to Lincoln Jr. High School -**1600 Lancer Dr. Walk-in.**

Follow Lancer to **1608 -CS**

Left on Vine, Right on N. Frey Ave. to **CBU 1**

Continue on N. Frey Ave. Left on Sycamore St. Left on Bryan Ave. to **CBU 2.**

Continue straight into driveway of **CS-1630 W. Vine Dr. (CR48)**

Retrace and right on W. Vine Dr. (CR48) **for CS – 2.**

Left on N. Briarwood Rd. to **CBU 3.**

Left on Bellwether Ln. right on N. Basil Dr. Ln. to **CBU 4.**

Continue on Basil, Right on W. Tarragon Ln. Right on N. Coriander Ln. to **CBU 5.**

Turn Left on W. Vine Dr. to service **CS – 3**

Right on Havel Ave and Retrace. Right on W. Vine Dr. (CR48)

Right on Theo Ave. to **CBU 6.**

Retrace form Theo Ave. Right on W. Vine Dr. to service CS4.

Retrace at Poudre Fire Authority Training Center. (**3400 & 3317 W. Vine Dr. NSD**)

Left on N. Overland Trl. Begin CS on Dean Dr. Right on Teal Dr. retrace. Right on Dean Dr. and retrace. Right on Ridgelawn Dr. Right on Lin Mar Dr. and retrace after **1124 Lin Mar Dr.** Left on Dean Dr.

Right N. Overland Trl. Right on Wakonda Dr. Right on Emery Dr. and retrace after **1133.** Right on Wakonda. Right on Belaire Dr. follow to right on Pintail Dr. Retrace. Right on Wakonda Dr. through **2603 Wakonda Dr.** Retrace back to N Overland Trl.

Right on Headwater. U-turn at Bubbling Brook Ct. to **CBU 7.**

Continue on Headwater to **CBU 8.** Continue to **CBU 9.** Continue to **CBU 10.**

Right on N. Overland Trl. To CS – 1430 N Overland Trl.

Right on Double Tree Dr. Left on Swing Station. Right on Spoke Ct. to **CBU 11.** Retrace on Spoke Ct. to **CBU 12**

Continue on Spoke – turns into Buckboard Ct. to **CBU 13** on Left.

Continue on Buckboard Ct. Right on Swing Station Wy. Right on Double Tree Dr. Right on N. Overland Trl. Right on Warson Dr. and retrace. Right on N. Overland Trl. Right on CR 21N and retrace.

Right on N. Overland Trl. Right on Bingham Hill Rd. and retrace. Cross N. Overland and continue on Bingham Hill Rd. U-Turn after **4916 Bingham Hill Rd.**

Right on Bingham Ln. and return after 2003 Bingham Ln. Right on Bingham Hill Rd. Right on N. Overland Trl.

Right on Shilo Dr. Right on Arapahoe Dr and Retrace. Right on Shilo and Retrace after 3516 Shilo Dr.

Right on N. Overland Trl. Right on Michaud Ln and Retrace after 4300 Michaud Ln.

Right on N. Overland Trl.

Right on Stargazer Ct. and return. Right on N. Overland Trl to 719 N. Overland Trl. Left on W. Vine (CR48) to service 2025 and 1705 W. Vine Dr.

Return to Post Office.

Continue on W. Vine Dr. (CR48). Right on S. Shields at roundabout. Left on W. Mulberry St. Left on S. Meldrum St. Right into Post Office Parking Lot.
